Dear Mesdames and Sirs,

The Tribunal refers to the Claimant’s email of 28 August 2019 seeking the Tribunal’s permission to extend by one week (i.e. until 9 September 2019) the deadline to file its Statement of Defense on Preliminary Objections, and to the Respondent’s email of the same day and its letter of 29 August 2019 requesting that the Tribunal reject the Claimant’s request for an additional extension, and if the Tribunal decides to grant the extension, suggesting further extensions to the subsequent deadlines.
